



Status of Church Plan Litigation

Below is a summary of current and recent church plan cases.

Case	Ruling/Status	Result
Chavies v. Catholic Health East District Court: Eastern District of Pennsylvania Jurisdiction: 3rd Circuit Year filed: 2013	District court denied Defendants' Motion to Dismiss. The court ordered discovery on whether the sponsor there at issue, a large hospital conglomerate, could be a "church" within the meaning of ERISA and thus establish its own church plan; the court did not reach plaintiffs' alternative arguments that the plan was not a church plan.	
Overall v. Ascension Health District Court: Eastern District of Michigan Jurisdiction: 6th Circuit Year filed: 2013	District court ruled that the pension plan there at issue was a church plan even though it was concededly not established by a church, but by a large hospital conglomerate; the court rejected plaintiffs' alternative arguments that the plan did not meet various other requirements to be a church plan. Appeal to Sixth Circuit.	On September 17, 2015, the U.S. District Court for the Eastern District of Michigan approved a settlement of the litigation.

Dignity Health District Court: Northern District of California Jurisdiction: 9th Circuit Year filed: 2013	District court ruled that the pension plan there at issue, sponsored by a large hospital conglomerate, was not a church plan because it was not established by a church; court did not reach plaintiffs' alternative arguments that the plan was not a church plan.	Interlocutory appeal to the Ninth Circuit, November 2014. Oral arguments in the Ninth Circuit were held on February 8, 2015.
Kaplan v. Saint Peter's Healthcare System District Court: District of	District court ruled that the pension plan there at issue, sponsored by a large hospital	On appeal by Defendants, the Third Circuit Court of Appeals held in <i>Kaplan v. Saint Peter's</i>

New Jersey Jurisdiction: 3rd Circuit Year filed: 2013	conglomerate, was not a church plan because it was not established by a church; court did not reach plaintiffs' alternative arguments that the plan was not a church plan. Saint Peters appealed to the 3 rd Circuit Court of Appeals.	Healthcare System, No. 15-1172 (3rd Cir. Dec. 29, 2015), that a hospital could not establish its own church plan, and because no church established St. Peter's Healthcare System's retirement plan, that it was ineligible for the church plan exemption from ERISA. On March 18, 2016, the 7 th Circuit denied Saint Peters' Motion for Panel and en banc rehearing.
Medina v. Catholic Health Initiatives District Court: District of Colorado Jurisdiction: 10th Circuit Year filed: 2013	Rejecting the recommendation of a magistrate judge, who had held that only a church can establish a church plan, the district judge held that a non-church could establish a church plan if certain other requirements were met.	
Stapleton v. Advocate Health Care Network District Court: Northern District of Illinois Jurisdiction: 7th Circuit Year filed: 2014	District court ruled that the pension plan there at issue, sponsored by a large hospital conglomerate, was not a church plan because it was not established by a church; court did not reach plaintiffs' alternative arguments that the plan was not a church plan.	On March 17, 2016, the Seventh Circuit Court of Appeals ruled in Plaintiffs' favor and held that under the plain language of the statute, "a plan must be established by a church." Because no church established the Advocate Health Care Network's Pension Plan, Advocate is ineligible for the church plan exemption from ERISA. On April 6, 2016 Advocate moved for a stay of the mandate pending filing of a petition for writ of certiorari.

		Plaintiffs filed a response pursuant to the Court's order. Advocate ordered to file a reply by April 22, 2016.

Morris v. Daughters of Charity Health System District Court: Northern District of California Jurisdiction: 9th Circuit Year filed: 2014	The hospital was sold during the litigation. The buyer agreed that upon closing of the sale the plan would be subject to ERISA.	On February 22, 2016 a voluntary dismissal of the case was filed.
